

## What are the Risk Factors for the Development of Metastasis in Patients with Cancer After Receiving the COVID-19 Vaccine?

### Abstract

**Introduction:** The majority of the studies after the COVID-19 pandemic are saying the necessity of cancer patients to receive the COVID-19 vaccine.

The purpose of this study is to demonstrate that patients with cancer have energy deficiency inside the five internal massive organs of the five elements theory of traditional Chinese medicine and the use of any kind of medication, vaccine, or devices such as the use of metallic implants in orthopedic or dentists surgeries can reduce even more the energy of these patients, worsening their immune system leading to more propensity to have metastasis after receiving the COVID-19 vaccine.

**Methods:** Three case reports. Two are females that have breast cancer diagnosed five years before the COVID-19 pandemic. Both received chemotherapy and three doses of the COVID-19 vaccine. One male patient had thyroid cancer (diagnosed four years ago) metastasis after receiving three doses of the COVID-19 vaccine. They were submitted to the measurement of the energy of the five internal massive organs of the five elements of traditional Chinese medicine using the radiesthesia procedure.

**Results:** All three patients were in the lowest level of energy of the Liver, Heart, Spleen, Lungs, and Kidney, rated one out of eight. Both females presented Lung metastasis diagnosed through the computed magnetic resonance and the male patient presented bone metastasis leading to spontaneous femur fracture. All these complications occurred after receiving the COVID-19 vaccine.

**Conclusion:** The conclusion of this study is to demonstrate that cancer patients have energy deficiency inside the five internal massive organs of the five elements of traditional Chinese medicine and the use of highly concentrated vaccines such as the COVID-19 vaccine can reduce even more this energy and cause more immune suppression, leading to more propensity to have metastasis in patients with cancer, as shown in these three patients reported in this article.

### 1. Introduction

Cancer is formed when there is an unregulated proliferation of malignant cells, invading organs and tissues and occasionally spreading through the body [1]. According to some studies found in the literature, if we analyze from the point of view of ancient medical traditions, cancer comes from energy deficiency and the formation of internal Fire [2,3]. The majority of studies found until today are recommending the necessity of vaccinating patients with cancer for the COVID-19 vaccine [4]. Also, cancer patients are

treated nowadays using many kinds of chemotherapy with the intention to kill the malignant cells [5].

**1.1 The Purpose of this Study** is to demonstrate the risk factors involved in cancer patients such as dietary aspects, energy alterations, medications used, and the use of some devices such as the use of cell phones and watches that can reduce our energy in addition to the use of the COVID-19 vaccine. To demonstrate that patients with cancer have energy deficiency inside the five

internal massive organs of the five elements theory of traditional Chinese medicine and the use of the COVID-19 vaccine in this type of population can increase the chance to have metastasis. The reduction of the vital energy caused by the type of methods used in the diagnosis and treatment of patients with cancer can also cause the reduction of these energies and can cause more propensity to have metastasis and this is what I want to demonstrate and describe in this article.

## 2. Methods

Through three case reports of patients that were in treatment for cancer and developed metastasis after receiving three doses of the COVID-19 vaccine. All patients gave verbal consent to publish their history recording their history to make this article. It also made a search for articles published on the internet PubMed on the topic of metastasis in patients with cancer after receiving the COVID-19 vaccine.

### 2.1 Case Report One

F.T. is 41 years old, married for 16 years, one son of eight-years-old. She has a diagnosis of left breast cancer in 2018. In the beginning, she felt a little lump of about 3 centimeters. It was hard and when she pushed the ball, it cannot move. She did so many laboratory and radiological exams at that time. She did an ultrasound and after, mammography that revealed that it was PC3. There was no history of cancer in the family. She was submitted to a biopsy that revealed that it was breast cancer. She was submitted to surgery to take out both breasts on March 2018. It was inserted breast prosthesis during the same surgical procedure. After the surgery, she began the chemotherapy sessions. It was weekly white chemotherapy totalizing 12 sessions. After, she began the red chemotherapy. During the chemotherapy sessions, she felt weak and had vomiting. Her hair fell and in the red chemotherapy, she became skinny and had stomachache. She had a habit to drink Cold cow's milk since when she was 9 years old. She also likes to eat a lot of yogurt and cheese. She usually drinks water mixing ice water with room-temperature water. She also likes to drink beer and eat a lot of raw salad. In 2020, she had a local recurrence of her breast cancer. At that time, she felt a little ball of about 2 centimeters in the same place as the breast cancer and she did not know that this could be possible because she took out both breasts. The doctor did a scraping and took out the lesion. After, he also did again the scraping to give a surgical margin and took out the lesion by surgery. She also was submitted to local radiotherapy only in the left breast. In 2022, she felt pain in the knee and in the rib. She was submitted to a bone scan and they did Lung's tomography, which concluded it was metastasis in both Lungs. She was using one iPhone watch three years ago and also, received three doses of the COVID-19 vaccine during this period. The first COVID-19 was made on June 7<sup>th</sup>, 2021 (Astra-Zeneca). The second dose was on August 25<sup>th</sup>, 2021 (Astra-Zeneca). The third dose was on December 21<sup>st</sup>, 2021 (Pfizer). After the new diagnosis of metastasis in both Lungs, she received six cycles of chemotherapy. She had a history of separation from her husband recently. Her past history was that in 2000, she met her husband and they married only in

2012. She said that he is very insecure and paranoid. He usually sees her cell phone to see if she was cheating on him, or putting a hiding camera to see all the things. In the beginning, her sexual life was good but after she became sick, she did not feel anything else. She was suffering from many emotional factors because her mother quite died after pneumonia. Her mother is characterized as a bipolar person. Her father is a very active person and helps her a lot. She has two sisters and one brother. She is the oldest daughter in the family. She also had another financial problem because her husband lost his job and stayed for 9 months in the home without any work. She went to my clinic recommended by an acquaintance to improve her energy. I suggested she measure the energy of her five internal massive organs (Spleen, Lungs, Kidney, Liver, and Heart) of the five elements theory of traditional Chinese medicine using the radiesthesia procedure.

### 2.2 Results of the Case Report One

All her internal five massive organs were in the lowest level of energy, rated one out of eight. According to traditional Chinese medicine, this weak state of the energy of these organs is responsible for any cancer formation and for this reason, it was important to me to restore the energy of these organs, that were responsible for our immune system to protect against the multiplication of malignant cells.

For this reason, it was implemented measurements to increase these energies and the first thing was to change the dietary aspects according to the thoughts of traditional Chinese medicine and Chinese dietary counseling. It was orientated to her to avoid the ingestion of dairy products, raw food, sweets, and Cold water because all these foods can induce Spleen and Pancreas energy deficiency and lead to less absorption of nutrients and less formation of Blood.

The second group of foods that it was orientated to avoid was the ingestion of coffee, soda, and soft drinks because all these drinks can reduce the energy of the Kidney, responsible for the production of *Yin* and *Yang* energy, important to our health.

The third group of foods that I orientated her to avoid was the ingestion of fried foods, chocolate, melted cheese, honey, coconut, and alcoholic beverages because all these foods can increase the formation of internal Fire, responsible for increasing the chance to have cancer or metastasis.

The second important tool used in her treatment was auricular acupuncture with apex ear bloodletting because using these tools, it was possible to regulate the internal energy of production of *Yin*, *Yang*, *Qi*, and Blood important to achieve health again.

The procedure of apex ear bloodletting was important to release the internal Fire, responsible for the increase in the chance to have cancer according to the reasoning used by traditional Chinese medicine.

To replenish the energy of these internal five massive organs, it was used highly diluted medications according to the theory created by myself (2020) titled *Constitutional Homeopathy of the Five Elements Based on Traditional Chinese Medicine* and crystal-based medications. The names of the medications used in her treatment will be shown in the discussion section.

The patient was living in another city 60 Km far from my city and did not return again after receiving five acupuncture sessions.

### 2.3 Case Report Two

S.B.S.R., 60 years old, dentist. She had a diagnosis of breast cancer on September 2016. She did surgery and received intravenous chemotherapy (white and red) every 4 weeks totalizing 6 sessions. Her hair was lost at that time due to red chemotherapy. She also had vomiting, nausea and feels very weak. She needs to use intravenous serum because she could not eat anything. Six years after receiving the chemotherapy, she began to feel dyspnea at the medical consultation. They did so many kinds of laboratory exams but did not reveal anything. Only the echocardiogram revealed that she was presenting cardiac insufficiency. But she does not have symptoms. The doctor prescribed four medications to control cardiac insufficiency such as Bisoprolol Fumarate, Spironolactone, and Dapagliflozin. During the last six years, she was using oral chemotherapy.

In the beginning, the doctor received Tamoxifen and said that she would not menstruate anymore. This medication gives her a lot of muscle pain that changes the location. The doctor prescribed another medication called Anastrozole but also gives her a lot of pain that she cannot pull over because the pain was enormous. She was using the medication for 6 years and in the cardiac insufficiency exam, doing a Lung tomography, it was discovered that she had two nodules, one in the right Lung and one in the left Lung (February 24<sup>th</sup>, 2022). She was submitted to a Lung biopsy that revealed that both nodules were metastasis of breast cancer. They begin to prescribe another chemotherapy called Selective that she was using every 28 days in the last year (two intra-muscular injections). She also has history of metallic titanium implants on teeth (2012, 2014, and 2019) and after breaking her feet in 2020.

Recently, during the COVID-19 pandemic, she also used three doses of the COVID-19 vaccine. The first COVID-19 vaccine was done on February 2<sup>nd</sup>, 2021 (Astra-Zeneca). The second dose was made on April 29<sup>th</sup>, 2021 (Astra-Zeneca). The third dose was on November 5<sup>th</sup>, 2021 (Pfizer). Even using all these chemotherapy medications, she is having some symptoms of dyspnea and she cannot know if these symptoms are caused by anxiety or by the metastasis in the Lungs. She went to my clinic recommended by her patient. I suggested she measure the energy of her five internal massive organs (Spleen, Lungs, Kidney, Liver, and Heart) using the radiesthesia procedure.

### 3. Results

The results of the measurement of her five internal massive organs (Liver, Heart, Spleen, Lungs, and Kidney) were in the lowest level of energy, rated one out of eight. The treatment of her condition rebalancing and replenishing the energy of these organs was very important to treat the causes of her breast cancer formation because since then, it was only treated her cancer itself but the energy alterations and deficiencies that led to this breast cancer formation was not treated yet. It was also used auricular acupuncture with apex ear bloodletting and systemic acupuncture every day four times a week. It was also used highly diluted medications to replenish the energy of all these organs using homeopathic medications created by Samuel Hahnemann (1755- 1843), but according to another new theory created by myself (2020) titled *Constitutional Homeopathy of the five Elements Based on Traditional Chinese Medicine*. It was used Silicea to replenish the energy of the Lungs, Natrum muriaticum to replenish the energy of the Kidneys, Phosphorus to replenish the energy of the Liver, Sulphur to replenish the energy of the Heart, Calcarea Carbonica to replenish the energy of Spleen and pancreas energy. It was also used crystal-based medications to replenish the energy of these organs and they will be shown in the discussion section. It was associated with the homeopathy called Carcinosisinun 200 CH used 5 drops per day and also, it was used the Chinese herbal medications called Long Dan Xie Gan Tang but used in a highly diluted form (I sent it to a homeopathy pharmacy and I asked them to dilute at 1 LM) and use 5 drops per day in apple vinegar.

I asked her to reduce the exposition to tomography (because the doctor was asking her to do it every two months to see if the metastasis was improving) and I will explain this conduct in the discussion section. She also has some lesions on the skin caused by itch in her arms and legs and after the acupuncture sessions, the lesion was lightening, and some disappeared. Her dark circles in both eyes were also reducing and I will explain it in the discussion section.

#### 3.1 Case Report Three

J. 37 years-old male patient with a history of spontaneous femur fracture (February 2023) when he was taking out his house trash without knowing the cause of his fracture. He was referred to another hospital and they asked for many exams such as a bone biopsy that did not reveal anything. In the bone scintigraphy (April 2023), it was discovered the possibly the fracture was caused by a metastasis of a thyroid tumor that he had four years ago (2019) that was treated using iodotherapy with an improvement in his health condition. In the investigation of the cause of the spontaneous bone fracture, it was also discovered that he had two metastases in both Lungs using scintigraphy. During the COVID-19 pandemic, he received three doses of the COVID-19 vaccine. The first dose (Coronavac) on July 22, 2021. The second COVID-19 vaccine (Coronavac) was on August 19<sup>th</sup>, 2021. The third dose (Pfizer) was in March 2022. After receiving the COVID-19 vaccine, he developed the SARS-CoV-2 infection but

did not have this infection prior to the vaccination. Two months before the fracture, he was feeling a local pain like the muscle was stretched. He went to my clinic because her wife was my patient and I asked him to bring him to me to measure the energy of the five internal massive organs (Kidney, Liver, Heart, Spleen, and Lungs) using a radiesthesia procedure.

### 3.2 Results

All his internal massive organs were in the lowest level of energy, rated one out of eight. The treatment of this condition rebalancing the internal energy of these organs using Chinese dietary counseling, orientating him to avoid the ingestion of dairy products, raw food, Coldwater, and sweets would reduce the Spleen and pancreas energy deficiency, responsible for the absorption of nutrients and production of Blood. It was orientated to him to avoid the ingestion of melted cheese, fried foods, eggs, coconut, honey, chocolate, and alcoholic beverages to reduce the formation of internal Fire, responsible for cancer formation. It was also orientated him to avoid the ingestion of coffee, soda, and matte tea because all these drinks can reduce the energy of the Kidney, responsible for the production of *Yin* and *Yang* inside the body. The second step in his treatment was submitting him to auricular acupuncture with apex ear bloodletting twice a week. The third step in his treatment was to replenish the energy of these organs using highly diluted medications such as homeopathic created by Samuel Hahnemann (1755- 1843) but according to the theory created by myself (2020) titled *Constitutional Homeopathy of the five Elements Based on Traditional Chinese Medicine*. Using this theory, it was possible to treat the Heart using Sulphur, replenish the energy of the Lungs using Silicea, replenish the energy of the Kidney using Natrum muriaticum, and replenish the energy of the Liver using Phosphorus. The treatment of this condition using these kinds of medications should be used for his entire life together with crystal-based medications, which I will mention in the discussion section.

### 4. Discussion

In many articles about cancer and the COVID-19 vaccine, the majority of them are saying the importance to give the vaccine to this group of patients [6].

But what I want to emphasize in this article is that we are facing a new phase of our planet where the energy of the whole population globally is changing and the evolution in terms of the production of the vaccine and medication for this new type of population that we are presenting nowadays are not accompanying the grade of all

these alterations [7].

The reason that I am saying these words is that the alterations that are happening nowadays cannot be seen by the naked eye because it is occurring at the energy level [8,9].

The part of the energy that composes the human body is not studied by Western medicine doctors since the implementation of the Flexner report in 1910. At that time, it was implemented regulations in all medical faculties that would be considered “scientific” only what could be proven by the laboratory or radiological level, and the part of the energy, that composes the human body was not included in this new rule [10].

Albert Einstein (1879-1955), the most famous physicist in our world said that “all the things in this universe are composed of energy” [11].

Hippocrates (460 a.c - 377 a.c) also said in his oath that “we need to consider other ancient medical traditions prior to the knowledge we have nowadays” [12].

In the book written by Capra (2010) titled *The Tao of Physics*, he is also saying about the different approaches between Western and traditional Chinese medicine and also considered all the things composed of energy [13].

So, in this article, I am using the reasoning used by traditional Chinese medicine, which existed for more than 5000 years, to explain which are the risk factors for the development of metastasis in patients with cancer after receiving the COVID-19 vaccine [14].

The progression from health to disease is divided into five phases and in the first three phases, there are energy imbalances but they do not exert alterations in the laboratory exams or at the radiological level, as I am showing in the article written by myself (2020) titled *The Importance of Treating Energy Imbalances and Chakras Replenishment for Prevention and Treatment of Cancer* [15].

For this reason, patients can have symptoms but the laboratory exams can be normal because the alterations that are causing the symptoms are in phases one to three, where the patient has symptoms but the laboratory exams are normal, as you can see in Table 1 [16-18].

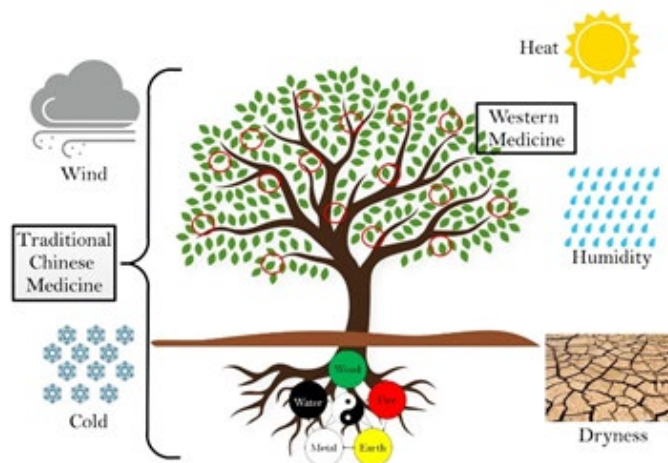

All this reasoning began when I treated one specific patient and I will tell you his history briefly to you to understand what I want to say in this article [19].

He was a 70 years-old male patient that was treated by myself in 2006 and his symptoms were pain in both legs but was not improving using anti-inflammatory medications for 6 months [19].

He went to my clinic to search for another type of treatment and instead of treating his symptoms, I treated his energy alterations, presented in the “root” of the tree, shown in Figure 1 [17-18].



**Figure 1: The Metaphor of the Tree Shows the Different Levels of Diagnosis and Treatment of Western and Traditional Chinese Medicine.**

You can see that this tree is composed of two parts, the part above the earth and the part under the earth [20-22].

The part above the earth is where Western medicine is doing in the diagnosis and treatment. This part is composed of the trunk and several branches and each branch means one medical specialty. Coming out of each branch, you can see many leaves. Each “leaf” means one symptom or disease treated by each medical specialty. In this case, the patient with leg pain was treated by Western medicine doctors at the “leaf” level, using anti-inflammatory medications to relieve the pain condition [14,15,17,18].

What I did was treat the energy imbalances presented in the “root” of the tree, that Western medicine’s doctors are not treating and it

is considered the cause of the formation of the majority of diseases according to the reasoning used by traditional Chinese medicine [15,19].

When I treated his energy imbalances presented in the “root” of the tree, his leg pain condition improved but he also improved from another condition that he did not tell me that was glaucoma [17,19,23].

He had been treating glaucoma for the last 40 years with no improvement only using eye drops and for the first time in his life, his intra-ocular pressure reduced from 40 to 17 mmHg when I treated his energy imbalances presented in the “root” of the tree [19].

After this case, I began to have many other medical experiences in the treatment of a variety of diseases, treating the “root” (the energy imbalances) and not just the symptoms [19,25].

In the article written by myself (2019) titled *Is It Possible to Treat Community-acquired and Nosocomial Infectious with the Same Method, Without the Use of Antibiotics?* I am showing that it is possible to treat these infections only by treating the energy imbalances presented in the “root” and not just treating the symptoms, using antibiotics [23].

Many other cases were presented by myself to show that by treating the “root”, we can treat all the patient’s emotional or physical conditions, including patients with cancer [15,22,25-28].

In the article written by myself (2022) titled *Energy Alterations in Patients with Malignant Thyroid Tumor and How Can We Treat It without Doing Surgery, Chemotherapy or Radiotherapy.* I am showing one case of a female patient that had a malignant thyroid tumor that was cured only by rebalancing the internal energy, presented in the “root” of the tree. It was not necessary to take out her malignant thyroid tumor because it became benign after this energy-based treatment [29].

For this reason, according to traditional Chinese medicine, cancer comes from energy deficiency and the formation of internal Fire [30].

The world that we are living in is not the same as in the past as I am showing in the article written by myself (2021) titled *Is the Population in the World the Same as in the Past?* [31]

In another article written by myself (2023) titled *New Global Immunodeficiency*, I am showing that we are passing through another phase of our planet that the population is considered immunodeficient due to the energy alterations that I found in the research that I did in my clinic in Brazil and published in another article written by myself (2021) titled *Energy Alterations and Chakras’ Energy Deficiencies and Propensity to SARS-CoV-2 Infection.* In this article, I showed the results of the measurement of the internal energy of the five internal massive organs (Liver, Heart, Spleen, Lungs, and Kidney) using a radiesthesia procedure. I concluded in this study that the majority of the population that I am attending in Brazil does not have any energy inside the five internal massive organs, responsible for the production of *Yin, Yang, Qi*, and Blood, which represent the cornerstone of all treatment in traditional Chinese medicine and the results is shown on Table 2 [8,32].

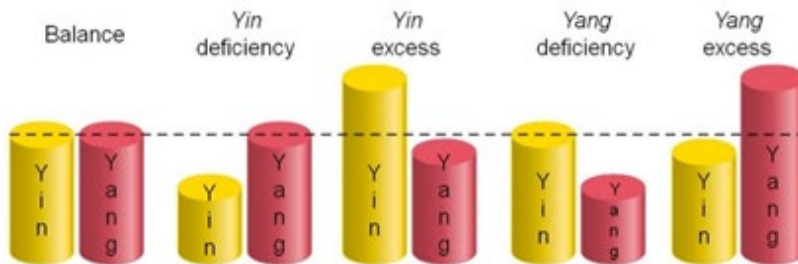
The energy alterations found are presented in the “root” of this tree, shown in Figure 1. At the “root” of this tree, there are two theories in traditional Chinese medicine, that are *Yin* and *Yang* theory and the Five Elements theory [17,18].

The *Yin* and *Yang* are two forces that exist in our universe that are responsible for the cycles of day and night, sun and moon, male and female, etc. They are represented by the symbol shown in Figure 2 [17,18].

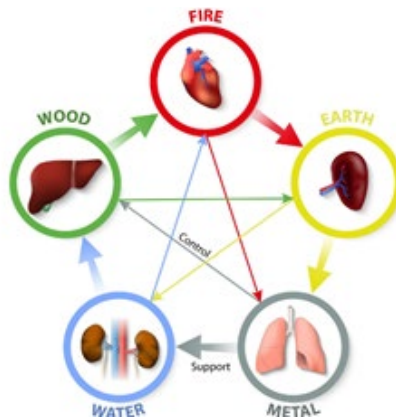
**Figure 3:** *Yin* and *Yang* Energy Imbalances and the Balanced State are shown in the Left Column.

There is the necessity to have a balanced state between these two forces and when there is an imbalance between them, there is the formation of many clinical manifestations in the “leaf” level of the tree. These energy imbalances are represented in Figure 3 [33].

The second theory in the “root” of this tree, is the Five Elements theory, shown in Figure 4 [17,18].

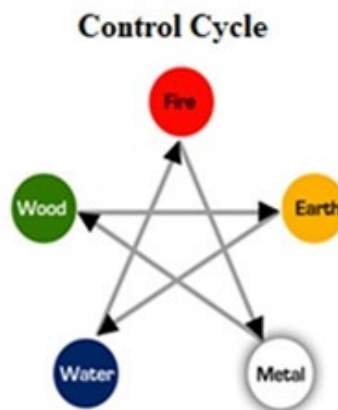
**Figure 5:** Five Elements and the Internal Organs that they Represent.

The five elements correspond to Wood, Fire, Earth, Metal, and Water and they have representations inside the human body, as you can see in Figure 5 [22,34].

Different from the Western medicine point of view, in this theory they understand that all organs work in conjunction and not separately. In this theory, each organ is sending energy to the following organ as you can see in the Generation cycle shown in Figure 6 [35].

There is another way to control the functioning of each organ, called the Control cycle, shown in Figure 7 [35].

The internal massive organs have the function of producing energy for the proper functioning of each external sensorial organ as you can see in Table 2 [36,37].

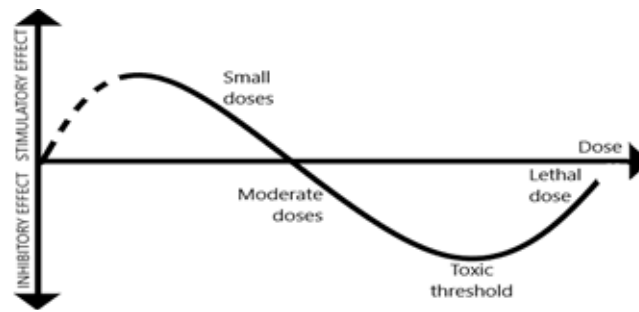
In this case, you can see that the Liver is commanding the functioning of the eye and vision. The Heart is responsible for the tongue and communication. The Spleen is responsible for the mouth and sense of taste. The Lungs are responsible for the nose and sense of smell. The Kidneys are responsible for the ear and hearing processes [38].

For this reason, the patient that I mentioned previously at the beginning of the discussion session treated his energy imbalances in the “root”, and improved from his glaucoma condition, even though I did not know about his eye problem because treating the “root”, we can treat all the patient’s symptoms at the same time, even the doctors do not know that the patient has such symptoms [19].

What I want to say explaining all these theories is that the production of energy to keep our health strong to prevent disease is very weak nowadays, because the energy responsible for the prevention of invasion of external pathogenic factors is not working normally, caused by the constant exposition to electromagnetic radiation after the implementation of 4G and 5G technology, leading to a decrease function of our immune system. These alterations are happening in the whole world because there are implementations of the modernization of the communication system globally [8,9,32].

For this reason, I showed through the article written by myself (2020) titled *The Importance of Treating Energy Imbalances and Chakras Replenishment for Prevention and Treatment of Cancer*, that all patients with cancer have in common, energy deficiency inside the five internal massive organs of the five elements theory of traditional Chinese medicine. The use of medications that could reduce these energies even more in these patients, even the use of chemotherapy to treat patients with cancer, has the potential to induce metastasis because it is causing a reduction even more of our internal energy, leading to a more weakness state of the patient’s body, causing more propensity to have metastasis, as I am showing in the article written by myself (2022) titled *Can The Use of Chemotherapy Induce More Formation of Metastases in Patients with Cancer?* [15,39]

In another article also written by myself (2022) titled *Why is Highly Diluted Oral “Vaccine” For COVID-19 the Safest Option in this Pandemic?* I am showing that according to the study made by myself (2021) titled *Energy Alterations and Chakras’ Energy Deficiencies and Propensity to SARS-CoV-2 Infection*, the population is very immune-compromised and the use of this type of vaccine, considered highly concentrated vaccine, can cause more energy deficiency, as I am showing through Arndt-Schultz Law, created in 1888 by two German researchers, shown in Figure 8 [8,40,41].

In this law, they are saying that the use of any kind of highly concentrated medications (in this case, including chemotherapy and any kind of the COVID-19 vaccine) can cause a reduction in this internal energy, reducing even more and causing more immunodeficiency, causing more propensity to have metastasis, as shown in the case report one, two and three [14,39].

In case report three, the patient had metastasis of a thyroid tumor that he treated four years ago (in 2019) and presented a metastasis to the femur after receiving three doses of the COVID-19 vaccine [42].

Not only the use of any kind of highly concentrated medications can induce the reduction of this vital energy but the use of any kind of metallic implants inside the body, such as dental metallic implants made of titanium or orthopedic devices made of titanium can cause a reduction of this energy, causing a reduction of our internal energy, that was proofed very compromised nowadays, causing more propensity to have cancer or metastasis in patients with a previous cancer diagnosis, as I am showing in the article written by myself (2022) titled *How Can We Prevent the Formation of Metastasis in Patients with Cancer?* [43]

In case report two, the patient was submitted to implantation of titanium implants in the teeth (the first implantation was in March 16<sup>th</sup>, 2012. The second titanium implantation was on August 14<sup>th</sup>, 2014. The third teeth titanium implantation was on August 30<sup>th</sup>, 2019) and she also implanted metallic titanium implants on her right feet (April 18<sup>th</sup>, 2020) after breaking her feet [44].

All these metallic implantations can reduce even more the internal energy of these patients that are already very low and can cause complications, in this case, the formation of metastasis. In the case of implantation of titanium implants in 2012 and in 2014, it helps to reduce the internal energy causing more propensity to have cancer. The third implantation on 2019 and 2020 increased the chance to have metastasis because reduced even more the internal energy, causing more propensity to disseminate the malignant cells after having the breast cancer [45].

Case report two also did so many kinds of exams such as computed tomography every two months to see if the patient has metastasis

or not. In this case, the radiation that these patients are submitted to is very high (because each tomography corresponds to 1000 rx rays approximately) and can reduce the internal energy, and reduce the immune system, increasing the chance to have metastasis as I showed in the article written by me (2022) titled *Can Malignant Cancer Worsen with The Use of Radiation Methods of Diagnosis?* [38]

The patient in case report two also was submitted to radiotherapy, which also induces the reduction of this vital energy, decreasing the immune system, as I am showing in the article written by me personally (2021) titled *What Are the Markers That Predict the Development of Having Cancer in the Future Without Laboratory or Radiological Tests?* [46]

Not only the use of radiation methods can increase the chance to have metastasis but the use of any kind of highly concentrated medications can also reduce even more the internal energy of patients with cancer and can increase the susceptibility to metastasis, as I showed in the case report two, who were using medications to lowering the estrogen in the body, it is also reducing her internal energy, causing more propensity to have metastasis [46].

Also, the use of chemotherapy in these patients also has the potential to reduce the internal energy even more, causing a weak state of the immune system, and increasing the chance to have metastasis, as I am showing in the article written by me (2022) titled *Can the Use of Chemotherapy Induce More Formation of Metastases in Patients with Cancer?* [39]

The use of cell phones and computers has the potential to reduce our internal energy, as I am showing in the article written by myself (2021) titled *The Influence of Cell Phones and Computers on Our Immune System*. In a case report one, the patient said she started to use an iPhone watch 3 years prior to having metastasis of her breast cancer. She also used her watch even during the sleeping process. In this case, the sleep process during the night is important to recover the energy spent during the day and if you the patient used this kind of watch during the night, it will take out all the energy that her body is storing for the next day and the patient will wake up very fatigated and weak to begin the day [45,47].

There are many studies published online, such as the study written by BBC News Brazil (2016) titled *How dangerous cell phone radiation is and how you can protect yourself* but they are studying the potential that these microwaves produced by cell phones could break the DNA to induce cancer [48].

The problem is that these waves are not affecting directly the DNA of the patients, but they are affecting the whole energy of the patient, which is responsible for the prevention of diseases nowadays, including the prevention of the formation of any kind of cancer, as I am showing in the article written by myself (2021) titled *How Can We Give Hope for Cancer Patients to Cure This Disease?* [24]

In case report one, the patient was suffering many kinds of emotional problems related to her separation. In patients with breast cancer, it is very common to see a history of emotional problems with their relationship and this is a point that we need to treat in any kind of cancer, as I am showing in the article written by myself (2021) titled *Chakras' and energy deficiencies in the genesis of breast cancer* [49].

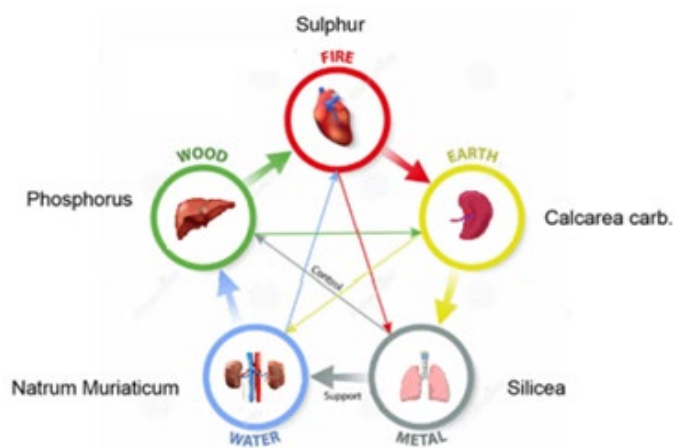
All patients reported in this article that have cancer and developed metastasis after receiving the COVID-19 vaccine used a combination of different types of the COVID-19 vaccine. The first case reported in this article used Astra-Zeneca in the first and second doses and received Pfizer in the third dose. The second case report received Astra-Zeneca in the first and second doses and received Pfizer in the third dose. The third case report received Coronavac in the first and second doses of the COVID-19 vaccine and received Pfizer in the third dose. In the article written by myself (2023) titled *Which Could Be the Risk Factors for Developing Cancer After Receiving The COVID-19 Vaccine?* I am showing that all five cases reported in that article that developed cancer after receiving the COVID-19 vaccine received a mix of different vaccines of COVID-19 [14].

As the whole world is immunodeficient caused by these energy alterations, I wrote another theory in homeopathy, looking at the “root” level, and not at the “leaf” level (used when we use the classic homeopathy). If we look at the “root” of the tree and put the “root” upside down, we can see the energy imbalances presented by each patient, and not look at the symptoms, usually used by the majority of doctors nowadays as you can see in Figure 9.

To treat this energy deficiency condition of the lack of energy inside the five internal massive organs, I use homeopathy medications created by Samuel Hahnemann (1755- 1843), but using them at the “root” level of the tree, as I am showing in Figure 10.



**Figure 10:** Homeopathy Medications are used in the Replenishment of Energy Inside the Five Internal Massive Organs

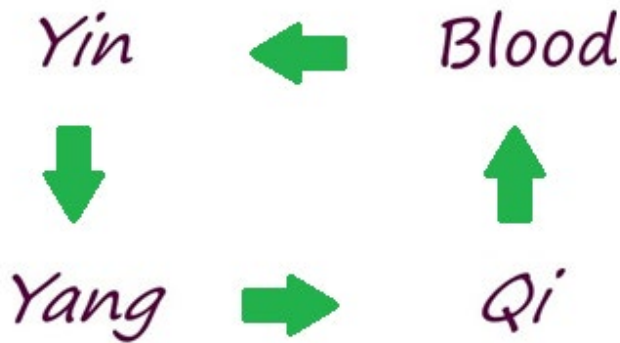
The part of the energy is not studied by Western medicine doctors since the implementation of the Flexner report in 1910. After this alteration, all medical schools in Canada and the United States changed their curriculum and considered “scientific” only what they could prove at the laboratory or radiological level [10].

According to Table 1, the progression from health to disease is divided into five phases, and in the first three phases, the patient has symptoms but the laboratory exams are normal. This usually occurs in patients with fibromyalgia, where the patient has pain in the whole body, caused by an energy deficiency situation, but the laboratory exams are usually normal. This does not mean that

the patient does not have anything. The patient is suffering from energy alterations that are not diagnosed nowadays, due to these implementations in the past, causing retardation in the diagnosis. Only after the patient has alterations in the exams, which can occur only after 5 or 10 years of energy deficiency situation, the physician can perform some diagnosis [16].

For this reason, to understand the risk factors involved in cancer patients have more propensity to have metastasis, we need to integrate the knowledge of Western medicine and traditional Chinese medicine, that exists for more than five thousand years, to understand wholistically the patient, looking at the “leaf” level of the tree but also, to the “root” level of the tree [14,39].

To balance these energies at the “root”, I usually use Chinese dietary counseling and auricular acupuncture, and systemic acupuncture, to regulate the *Yin*, *Yang*, *Qi*, and Blood energies, as they are the cornerstone of all treatment in traditional Chinese medicine, as I am showing the interrelationship between these energies in Figure 11 [17-18].

In the Acupuncture Research Conference, that was held at Harvard Medical School in Boston, in 2015, I presented one study saying that “if we treat the energy imbalances shown in Figure 11, we can treat all the patients’ conditions at the same time, even the doctors do not know that the patient has such symptoms” [19].

The first tool used to balance the internal energy of *Yin* and *Yang* is to change the dietary aspects using the energy of each food to regulate the internal energy of *Yin*, *Yang*, *Qi*, Blood, and the formation of internal Fire, responsible for the formation of any kind of cancer according to TCM [15].

In case report one, she likes to eat dairy products and even uses surgery and chemotherapy to treat her breast cancer, she had a relapse of the tumor and this occurred because of many factors. First, the part of energy deficiency and formation of internal Fire was not treated after the surgery. Western medicine doctors only treated the “leaf” level of the tree, but the “root” of the tree still has

energy deficiency [15,49].

It was not changed her dietary aspects according to the energy of each food. According to Hippocrates (460a.c - 377a.c) the father of medicine, “We need to use our food as our medicine and our medicine as our food”. Patients with a history of breast cancer cannot use any kind of dairy products, raw food, or Coldwater, because the ingestion of these kinds of foods can induce more energy imbalances of the Spleen and Pancreas energy, responsible for the formation of Phlegm, one of the energy imbalances responsible for the formation of tumors, especially breast tumor [12,48].

Case report two had metastasis in both Lungs after receiving the COVID-19 vaccine. She was using chemotherapy since she took out the breasts, and she also had many expositions to radiation from tomography and other exams. She was exposed to radiotherapy which caused a reduction in her internal energy. Also had the necessity to implant titanium implants in the teeth. After she broke her feet, she also received metallic implants in her feet. All these factors could reduce even more the internal energy that can contribute to the formation of metastasis. But only after receiving three doses of the COVID-19 vaccine, the last dose on November 5<sup>th</sup>. 2021, she developed metastasis in both Lungs, diagnosed on February 2022 [14].

In case report three, the patient had metastasis to the bone and caused a spontaneous femur fracture after receiving three doses of the COVID-19 vaccine. The patient had a malignant thyroid tumor four years (2019) before and was not feeling anything after the treatment. Only had this fracture after receiving three doses of the COVID-19 vaccine, which is considered a highly concentrated vaccine that reduced his internal energy, responsible for his immune system [42].

For this reason, I wrote another article (2022) titled *Why is Highly Diluted Oral “Vaccine” For COVID-19 the Safest Option in this Pandemic?* In this article, I am showing that due to the energy alterations presented in these patients caused by chronic exposition to electromagnetic radiation, as shown in the article (2021) titled *Energy Alterations and Chakras’ Energy Deficiencies and Propensity to SARS-CoV-2 Infection* we need to use highly diluted medications in the prevention and treatment of the majority of diseases nowadays, including patients with cancer [8,40].

This group of patients, they have energy deficiency inside the five internal massive organs, and each organ is responsible for the formation of internal energy to allow our good health. If the organs are not working normally, the production of these energies is very compromised, causing more propensity to have many kinds of chronic diseases, such as hypertension, diabetes, autoimmune disease, or even cancer. In patients with cancer, if we use any kind of procedure or medication, or vaccine that can reduce these energies, which is already very low, we can induce more

immunodeficiency and cause more propensity to have metastasis in patients with cancer [14,39].

In case report three, it was used to fix the fractured bone, one titanium implant inside the right femur. This metallic implantation could reduce even more the energy of this patient, which was already low, and cause a propensity to have any kind of complication caused by energy reduction, such as thrombosis, myocardial infarction, tremors, auto-immune disease, diabetes, etc, or even more metastasis or the formation of another tumor [14,15,25,27,28,45-51].

In Brazil, acupuncture and homeopathy are considered medical specialties by the Federal Medical Council since 1995 and 1980 respectively [52].

To understand which are the risk factor inducing more formation of metastasis in patients with cancer after receiving the COVID-19 vaccine, we need to integrate the knowledge of Western and traditional Chinese medicine, that exists for more than 5 thousand years, to know the “leaf” level and also, the “root” level of the tree, showed through the metaphor of the *Yin* and *Yang* of TCM and Western medicine, in Figure 12 [19,25].

**5. The Conclusion of this Study** is to demonstrate that the risk factors involved in cancer patients are emotional or wrong eating habits or the use of devices that could reduce the internal energy of these cancer patients even more. In this study, I am showing that emotional factors are important and should be treated. Also, there are wrong eating habits that are not usually treated accordingly. All patients with cancer have energy deficiency inside the five internal massive organs. The use of any kind of medication or therapy that could reduce even more these energies can increase the chance to have metastasis. The use of any kind of highly concentrated vaccine or medication such as chemotherapy, the use of electromagnetic radiation such as iPhones and computers, and metallic implants such as teeth implants and bone implants, have the potential to reduce the internal energy of the patient and can increase the chance to have metastasis in these patients. The use of the COVID-19 vaccine, can reduce even more this internal energy (being a highly concentrated vaccine) and can increase

the chance to have metastasis in patients with previous diagnoses of cancer. There is a necessity to have more studies in this field involving other types of vaccines (that are also considered highly concentrated vaccines).
